This was done to minimize risk for our workers, volunteers, contractors, and participants. The event was originally scheduled for May 15 and 16 as a means for households, farms, and qualifying businesses to safely dispose of unwanted chemicals. If you were planning on attending this event, please hold onto your chemicals until the fall collection. CHAIRMAN'S COMMENTS

I am happy to share with everyone that the Town of Newton had another good year! Please see below information and highlights from 2019.

Newton Road Project Completed.

In 2018 we began filling in the shoulder of Newton Road, West of Willever Lane. The DNR inspected the area many times throughout Spring and Summer. In August they requested that we remove ground from the ditch on the North side of the road. We honored their request and they were satisfied. The area that was black-topped on Newton Road amounted to \$162,874.00.

More Road Improvement Information.

Chip sealing was done on Clover Road (from Gass Lake Road to Cty. CR), Clover View Road, Harley Road and Davidson Road. Total cost of the project was \$32,866.00.

A total of \$238,561.92 was spent on all road improvements for 2019. (This includes culverts, black topping, sealing, center striping and redoing two roads with gravel.

Grant Updates.

In Fall of 2019, we applied for three 90/10 grants for the Town, which means the State would pay for 90% and the Town would pay for the remaining 10%). The three grants consisted of one for Newton Road and two for Gass Lake Road. In February, the Town was informed by the State of Wisconsin that the grant for Newton Road was approved, but that it was reduced to 70% instead due to the mass number of grants they received from others. We have six years to use this grant.

One of the grants we received back in 2016, that needs to be used by the end of 2020, will go towards repairing English Lake Road from Custer Road to the West.

Building Permits/Improvements in the Town of Newton.

In 2019, \$5,658,404.06 of improvements took place in our town. This is according to the building permits that were issued.

City of Manitowoc Ambulance Contract.

The Town has signed a new ambulance contract with the City of Manitowoc. The contract amount remained the same which is \$5.00 per person. The Town's population is 2309 which amounts to \$11,545.00 for 2020. This is a five year contract.

Reminders for Town Members.

The Recycling Center will be closed on July 4, 2020. Please plan accordingly.

SUPERVISOR ONE'S COMMENTS

The year 2019 had some challenges, but also some rewards. I wrote the 90/10 Grants from the State of Wisconsin that was a one time grant for road improvements in the State. I wrote three road grants which were Newton Road and two sections of Gass Lake Road. I was very excited when I heard that the Town of Newton was awarded the grant for Newton Road! This is huge for the Township of Newton residents because the dollar amount of this grant is over \$220,000. Of all the grants that were applied for only ten per cent of the grants were awarded. I was happy to hear that we were one of the small percentage that received the grant. Keeping this in mind the State asked if we would take seventy per cent payment of the total bill on Newton Road. My reply, when asked, was YES! This was worth my week of no sleep and hoping to get at least one grant from the State because I felt this was so important to show our residents how much I care about saving money for the town and being responsible as your supervisor.

The transfer station has been running very smoothly thanks to the attendants that we have to conduct business there each Saturday. Please give a big thank you to Ray, Al, Ed and Jim for keeping our transfer station in order for all of our safety. Please remember to keep your aluminum cans clean of bags, food, foil, etc. We do have a new large container for the glass which is a lot shorter so it will be easier for all of us to empty our glass in to it. Please keep in mind that we do recycle items. We are seeing a decline in the payback of recycled products so if you see changes in the future it is to keep our transfer station sustainable. If you have any questions or comments, please feel free to reach out to me or any of the guys and we will get the matter handled promptly.

I, as your Town Supervisor, believe I am here to look out for the betterment of you, the town residents, and also see that sound decisions are made in your best interest. Sometimes I am not the popular person in the room, but that comes with the job.

ZONING PERMIT FEES:

Our zoning administrator is Mike Slattery. Conditional Use, Variance and Zone Change Requests require an on-site inspection and a public hearing. The process takes several months. Allow yourself enough time. There is a charge.

BUILDING PERMIT FEES:

Our Building Inspector is Roger Mayer. The question is which signs require a permit and which ones do not. Signs in Business and Industrial Districts require a permit and must be approved by the Plan Commission. Each individual business is limited to a total of two signs. All signs, including all components, shall be set back a minimum of five feet from any property or right-of-way line. There is a sign permit fee.

The following do not require a sign permit:

1. Agricultural signs that pertain to the sale of farm products and not more than 32 square feet.
2. Real estate signs not more than 8 square feet.
3. Bulletin boards for public, charitable or religious institutions.
4. Memorial signs, tablets and names of buildings if cut into masonry surfaces.
5. Election signs with property owner permission.
6. Banners when authorized by the Plan Commission.

Flashing signs are not allowed and no sign shall contain moving letters or parts.

New Zoning Ordinance Books are available. The cost is \$20.00. Photo-copies cost .25 a page.

Also permits are required for changes that affect the market value of your property:

1. A sanitary permit is required for charges that affect the market value of your property.
2. Setback of variance permits from Manitowoc County Planning and Parks Department are required on all new construction.

PERMITS – (CONTINUED)

3. The Town of Newton requires building permits for all construction that is not considered minor repairs or general maintenance.

PERMIT REQUIRED:

A. Maintenance:

Repair walks.
Repairing gutters and down spouts.
Repairing porches and steps.
Repairing original siding.
Patching or repairing interior walls and ceilings
Exterior painting.
Replacing electrical Fixtures.
Replacing furnace.
Repair or replace weather stripping, screens,
storm windows and doors.
Exterior landscaping.
Replacing existing shingles.

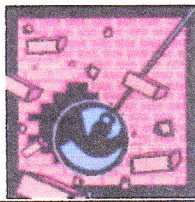
BUILDING PERMIT REQUIRED:

B. Assessable Items:

New homes, garages, sheds, barns.
Additions (any changes to the foot
print of the building such as decks,
ports, canopies.
Replacing older siding with aluminum or
vinyl siding.
Substantial modernization of kitchens or
baths.
Central air-conditioning.
Fireplaces
Extensive Remodeling
Recreation rooms or finished basement.
Window replacement if size changes or
the type of glass changes. (single to double pane, etc.)
Outdoor furnaces.

MOVING PERMITS

A moving permit is required for all buildings being moved on roads within the Town of Newton. The moving permit can be obtained from the zoning administrator. The sheriff's department should also be notified about such move.



WRECKING PERMITS

Any building being torn down, removed or burned by the Newton Fire Department should obtain a wrecking permit from the zoning administrator. There is no charge for this permit. Obtaining this permit insures that the building will be taken off of the tax roll.

ASSESSOR

Occasionally a town assessor may need to enter into land to update information to establish fair assessment value for each property. No entry into a building or dwelling will ever be made without consent. However, entry onto lands including lands around buildings is assumed unless a written notice is provided to our assessor to keep off your land. If an assessor is not allowed access for viewing property, an owner cannot contest at the Board of Review the assessment level set by the assessor (Sec. 70.47(7)(aa) of Wis. Stats.

DRIVEWAY AND CULVERT ORDINANCE

The Town Board has passed a Driveway and Culvert Ordinance. All residents in the town must have a permit for installing new driveways, new culverts or extending, replacing or repairing existing driveways or culverts. There is a \$50.00 fee for driveway or culvert permits. This permit may be obtained from the road superintendent, Dave Mueller, at the town shop. If you cannot get in touch with him leave a message on the answering machine at the shop. The telephone number is (920) 758-2338.

BURNING ORDINANCE

The Town of Newton has a Burning Ordinance. Violation of this ordinance can and will result in a fine. If found in violation, the first offense is a \$25.00 fine plus court costs; the second offense is a \$50.00 fine plus court costs; the third offense is a \$100.00 fine plus court costs; and the fourth offense is a \$200.00 plus court costs. Copies of the ordinance are available at the Recycling Center and the Newton Town Shop.



BURNING PERMITS

Burning Permits are required for all fires unless made in a barrel, trash can or other enclosed burner that has a heavy screen or cover to prevent burning material or embers from blowing out. Burning permits are available at Stock Mfg., Highway 42 Garage, Pine River Dairy, Recycling Center, Tom Hochkammer, Fire Chief, Terry Wagner First Assistant Fire Chief, Second Assistant Fire Chief Dan Stock or Dave Mueller, Road Superintendent at the Town Shop.



RECYCLING

A big thank you to Al, Ed, Jim and Ray for the work they do at the Recycling Center. They are appreciated!

Recycling guideline information is available at the Recycling Center. Due to Wisconsin State Law, a number of items previously accepted must now be refused. A comprehensive list is available at the Recycling Center with referrals for appropriate disposal. The attendant in charge has complete charge of the Recycling Center and the right to refuse any material not in compliance with Town, County and State recycling rules and regulations.

Paper and cardboard does not have to be separated. Paper, books and magazines must be bundled and bagged. Shredded paper must be enclosed in tied plastic bags or taped boxes. Boxes have to be flattened unless filled with paper or cardboard.

The blue container at the Recycling Center is not for garbage. It is clearly marked "Copper Only". When you are done emptying your glass or tin cans into the appropriate bins, then please bring the paper or plastic bag that contained those articles to the compactor for disposal. No bags or string allowed in plastic containers.

Please clean your glass, plastic and cans. Besides being one of the requirements for using the Newton Recycling Center, this will also help cut down on the bee problem during the warmer months.

POSTING BOARD

Meetings are posted on the posting board outside of the Town Hall, Hi-Way 42 Garage, CR Stop as well as at the Town of Newton web site which is: townofnewton.org.

DEPOSIT BOX

There is a deposit box located on the East side of the entrance to the Town Hall for payment of your FIRST real estate tax installment which is due January 31st as well as your dog's vaccination papers. This box is locked and is secure. After January 31st property taxes should be paid/sent to the Manitowoc County Treasurer at the Court House, 1010 South 8th Street, Manitowoc, WI 54220. Dog licenses should be paid to the Town of Newton Treasurer, Paulette Vogt, 8525 Carstens Lake Road, Manitowoc, WI 54220.



FIREWORKS PERMIT

The Town of Newton does have a Fireworks Ordinance in effect. Any fireworks that exceed the limits as set by Wisconsin Statute 167.10 must get a permit which can be obtained from the Town Chairman at the June Board Meeting.



DOG LICENSES

All dogs must be licensed and have their rabies inoculation by April 1 or you will be notified by the Law Enforcement Officer. Non-compliance will result in a \$35.00 late fee per owner. Contact Paulette Vogt, Treasurer, Phone (920)758-2720 for a license. Only authorized town officials are authorized to take animals to the Humane Society.

2019 marks the end of our 72nd year of providing fire protection and prevention to the people and businesses of the Town of Newton. We constantly train and learn to provide you with the best fire protection services. In 2019, the Newton Fire Department responded to 61 calls which were the following in nature:

Vehicle accidents: 20	Fire Alarms: 3	Public Service Calls: 4	Structure fires: 10
Miscellaneous: 12	Cancelled calls: 12	Mutual Aid Calls: 7	

This past year, the Newton Firefighters, with the support of the community, invested \$120,000 into improvements to the Newton Firefighters Community Park. We put \$6,000 toward the purchase of the new equipment vehicle. Through our annual bowling tournament, we have raised and donated over \$165,000 to Children's Hospital of Wisconsin. We are very proud of being financially responsible and giving back to the community we serve.

Remember, you need to have a burning permit for any burning project not contained in a barrel or pit. Burning permits can be obtained from any of the fire chiefs, or during business hours at Hi-Way 42 Garage, Stock Manufacturing, Pine River Dairy, the Newton Town Shop, or the Newton Recycling Center.

If you have an emergency, call 9-1-1---and tell them what your emergency is, the address of the emergency, and the phone number you are calling from. It is your responsibility to keep your address sign clear of snow and brush so that the signs are easily readable. This allows us to quickly find you in an emergency. Be sure to change the batteries in your smoke alarm and carbon monoxide alarms yearly.

Newton First Responders have been providing this community with pre-hospital care for 32 years. We strive to provide the best pre-hospital care to those people we help. Remember, that anyone who needs pre-hospital care, emergency or non-emergency in nature, can access the services of the Newton First Responders; 24 hours a day, 365 days of the year; all at no cost to the patient. Behind the promise of good, quality care, is our commitment to maintain the high standards we have set for our organization. The members of the Newton First Responders have committed 281 hours of time for meetings, drills and schooling, and 653 hours of time on calls, for total of 934 hours this past year. Certified by the State of Wisconsin, the Newton First Responders provide the most up to date First Responder care and skills.

In 2019, the Newton First Responders responded to 136 calls. These calls included contact with 125 patients. 90 or 72% of these patients were transported to hospitals for further care. 64 calls or 47%, were medical calls for complaints of shortness of breath, chest pain, or other illnesses. 23 calls or 17%, were trauma related calls such as falls and 20 or 15%, were motor vehicle crashes. 11% of the patients received oxygen as part of their treatment. The UTV rescue vehicle was used at 5 events.

The Newton First Responders presently consist of 9 active members. 3 of these members are also members of the Newton Fire Department and 1 member are trained to Emergency Medical Technician (EMT) level or higher.

Applications are being accepted for additional members.

Any interested persons can contact Mark Knier at 901-3373 or Debbie Holschbach at 323-0497 or any responders listed below. Classes for First Responders are usually held several times in the year.

Please remember that when you have an emergency, dial **911** immediately. The First Responders will be dispatched along with an ambulance. Turn on an outside light or have someone wait at the end of the driveway to help us find you and help you.

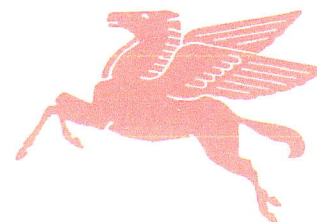

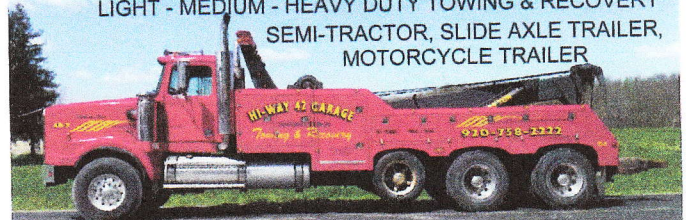
