

# TOWN OF NEWTON

## 2022 TAX SEASON

Enclosed is your statement for the 2022 tax year. I would like to thank you for the support and cooperation that you have shown me this past year. The "locked drop box" at the Town Hall has been working very well. It is located just to the right of the front glass doors of the Town Hall. I collect payments from this box each and every day during the tax season. I will also be collecting payments by mail at my home. If you would like a receipt for your tax payment, you can either include a self-addressed stamped envelope for a return receipt or you can include your email address and I will email your receipt back to you. **PLEASE REMEMBER THAT THE TOWN CAN ONLY COLLECT PAYMENTS THROUGH JANUARY 31, 2023.**

**After that date, payments must be sent to the Manitowoc County Treasurer's Office as noted on your Tax Statement.** These payments should **NOT** be dropped off in the Newton Town Hall drop box. The use of the drop box after January 31, 2023 may delay your payment to the County and cause an interest penalty to be assessed.

**WHO NEEDS A LICENSE:** *Every person who owns, harbors, or keeps a dog more than five (5) months of age on January 1, or five months of age within the license year shall annually, or within 30 days from the date such dog becomes 5 months of age, pay the dog license fee and obtain a license as provided by the provision of Chapter 174 of the Wisconsin Statutes.* Dog license, due April 1, 2022, are \$6.00 for fixed dogs and \$11.00 for dogs that are not fixed. Payment can be sent in with your tax payment. Vaccination papers, or a copy of the same, with your payment is required. We have found it is a lot easier to pay for the dog tags at tax time so the chance of forgetting by the deadline will not happen. (The fine for late fees for dogs is \$35.00 after April 1, 2023). The dog tag payment does not need to be a separate check and you do **not** need to include a self-addressed stamped envelope for it. The dog tag, along with your vaccination papers, will be sent back to you. I will continue to be available by phone (920/758-2720) for any questions you may have. If I am not available to take your call, please leave a message and I will get back to you as soon as I can.

NOTICE: We now have garbage bag stickers instead of coupons. You will now use your own garbage bags and the cost for recycling will be @ \$1.50 per bag with a sticker. Those Town Residents that had received coupons with their taxes will now receive the Town stickers instead. These stickers will also be sold at the Recycling Center for a cost of \$1.50 per sticker. The remainder of your "NEWTON BAGS" will be accepted at no extra charge. Please see the Recycling Attendant if you have questions. Thank you.
