

TOWN OF NEWTON BOARD MEETING (Rough Draft)

December 28, 2023

The December 28, 2023, meeting of the Town of Newton was called to order by Chairperson Thomas at 10:00 a.m. at the Town Hall, 6532 Carstens Lake Road, Manitowoc, WI.

ROLL CALL

The roll was called, and members present were Denise Thomas – Chairperson, Kevin Behnke – Supervisor 1, Kelly Christiansen- Supervisor 2 – Paulette Vogt – Treasurer, Dave Mueller – Road Supervisor/Law Enforcement Office. Excused: Mike Slattery – Zoning Administrator, Alyssa Grotegut - Clerk.

VERIFICATION OF POSTING – APPROVAL OF AGENDA & MINUTES

An affidavit is on file showing the agenda was posted in the proper posting places. Supervisor Christiansen moved to approve the agenda, seconded by Supervisor Behnke, all approved, motion carried.

REPORTS

Chairperson – Chairperson Thomas introduced Greg Grotegut, Manitowoc County Highway Commissioner. He explained the Jurisdictional Transfer of CTH CL, on the map that he presented. After the discussion with the board and Greg a motion was made by Chairperson Thomas, The Town of Newton is accepting the transfer of CTH CL or Viebahn Street from Hecker Road to S 26th Steet. The estimated mileage for the Town of Newton will accept is .25 and the City would accept 1.25 for a total mileage of 1.5.

Effective January 1, 2025 – City of Manitowoc will take over maintenance October 1, 2024. Second by Supervisor Behnke. Motion carried.

Manitowoc County and the City of Manitowoc is requesting that the Towns start collecting the GTA funds for these sections and transfer those funds back to the City of Manitowoc for maintenance annually moving forward.

Next was the P&L for 2023. By Budget Resolutions we will transfer unused funds to the Committed Fund. Committed Fund is \$134,789.57 before the resolutions. After a discussion, Chairperson Thomas made the motion to move by Resolution No. 1228203 Chart of Accounts #44300 - \$9635., #48110 - \$26,460., #53300 - \$16,500., #53306 - \$10,000., #53307 - \$5000., #53308 - \$5000. for a total of \$72,595. to Chart of Account 57900, and by Resolution 12282023A to move from Chart of Account #43791-40, 893.50 to Chart of Account 57900. Bringing the total of Committed Fund to \$248,278.00. Motion was second by Supervisor Behnke, motion carried.

ADJOURN

With no further business Supervisor Behnke made a motion to adjourn the meeting and seconded by Supervisor Christiansen. Motion carried.
