The current water project, hydrant issue is currently between our attorney and the cities attorney. A discussion of changing the Town's bank was had and we will revisit at the January Meeting. Supervisor Behnke made a motion to approve moving the CD money of \$280,390.98 to Cleveland State Bank for 24 months at 3.75% rate. Supervisor Behnke made a motion to approve the Joint Powers Agreement, seconded by Supervisor Downing, all approved, motion carried.
